Intervention teachers will be hired at each k-6 elementary school to target at risk students. Decisions will be made from beginning of year aimsWeb and AlaKids assessments. In the area of reading SPIRE (a evidence-based program) will be used for instruction. In the area of math Reflex Math will be used as an instructional tool. Students will be reevaluated informally through out the year and a benchmark assessment will be given mid and end of year. Students served will be based on this data. The groups will be fluid and changed as students' needs change. \*\*\*Salary \$17,700.00 and Benefits \$1,341.00

After school program for high school students: 3 teachers per school (total 9), 3 hrs per week, 31 weeks, \$25.00 per hour (\$20,925 Salary + \$4,194 Benefits) At the high school level, Scantron and pre-course assessments will be used to determine student groups. Subject specific teachers will work with students that need assistance in their area of expertise.

Classworks, an evidence based program will be used to remediate and provide learning paths for students that are struggling. (\$30,000.00)

Classroom materials and supplies to include progress monitoring materials and manipulative to use with SPIRE. (\$30,737.00) Total for all above: \$134,855.00

Communication with parents/guardians will be made by teachers either face to face, telephone, email, virtual classroom, Dojo, Remind etc.

We are also making Classworks, Renassiance and other online programs like Reflex Math available outside the regular school day. Teachers will communicate with students and parents on what can be worked on outside school instructional time to help close the gap for our vulnerable population.

## 2D. Before/After School Tutoring

K-3 students who need additional instruction will be identified through aimsWeb Plus and AlaKids beginning of year benchmark tests. Teachers who have been trained or who are being trained in the science of reading will be employed for the extended day program. Selected teachers will provide the needed support, as identified by benchmark screening, using an evidence-based program (SPIRE). Instruction will be based on student needs and adjusted as needed. Teachers will work with reading coach, teachers and administration in planning and implementing a targeted program of instruction designed to meet individual needs of students.

1.5 hours per day / 2 days a week @ \$25.00 per hour 31 weeks (throughout 20-21 School Year) Total personnel will be 15 people (5 at each elementary school).

\$34,875.00 salary and \$6,993 for a total of \$41,868.00 salary and benefits.

# How will the LEA plan for implementation and measure impact for effectiveness for purchases identified?

Teachers will be secured for each after school program and start on September 14, 2020. Informal assessment will take place regularly and benchmark assessments/post course tests will be given at beginning, middle and end of year. The data will be analyzed and gains will be documented by data teams. The data gathered beginning and mid year will be used to target instruction.

Classworks will be used to provide students at school and at home with additional targeted instruction in areas of need. Benchmark assessments are also available to measure progress. End of year data will determine the effectiveness of this program we will use throughout the year.

Progress monitoring materials and supplies will be used to implement the after school program and for teachers to use tracking the progress of identified students. These materials allow the teachers to do one-on-one progress monitoring. Improvement can be tracked between each progress monitoring period.

What is the proposed timeline for providing services and assistance to students and staff?

The start date for the after school program is September 14, 2020 and the end date will be May 14, 2021. The program will be carried weekly throughout the whole school year. Computer program and materials will be used starting with school (August 31, 2020) and used throughout the school year (May 28, 2021)

All services will conclude on or before September 30,2022.
